>>> On Tuesday, October 15, 2013 I received and deposited an inheritance  
>>> check.  
>>>  
>>> On Thursday, October 24, 2013 all the funds became available to me.  
>>>  
>>> Today, Monday, October 28, 2013 is within the five day notification  
>>> that it is my understanding that I need to inform LA DPSS of these  
>>> facts.  
>>>  
>>> It is also my understanding that if by the end of the reporting  
>>> period that I have funds of more than \$1500 then I will be  
>>> disqualified from continuing to receive general relief also known as  
>>> GR.  
>>>  
>>> It is also my understanding that if I do not receive some unknown  
>>> exact amount over \$1600 per month than I am not disqualified from  
>>> receiving food stamps. So, if my understanding is correct on the  
>>> issue of food stamps I would like to continue to receive food stamps.  
>>>  
>>> Since I do not believe that there are any more urgent reasons for me  
>>> to be aware of letters sent to me via the United States Postal  
>>> Service would you please change our mailing address to the following:

>>> For your information and for the record we are picking up the mail  
>>> once every 2 to 4 weeks. However, I will continue my current  
>>> practice of checking the LA DPSS website once a week to see if there  
>>> are electronic notices posted on that website.  
>>>  
>>> I would also like to correct something that has caused my wife Gail  
>>> and I a great deal of physical pain and agony which is not having a  
>>> separate EBT card for her so that she can just go into a store and  
>>> purchase a small number of items such as milk and bread without  
>>> having to have me be brought into the store utilizing a wheelchair  
>>> whether Manual or electric.

>>> So that no further misunderstandings develop between myself and LA  
>>> DPSS I did not create this document by using my hands to type it  
>>> since I had previously stated that because of the neuropathy in my  
>>> hands I would not be able to type such a letter.

>>> understanding that I would be notified immediately and no later than  
>>> five days from the date of this memo by e-mail. That same  
>>> expectation applies if there are any questions about what I have  
>>> stated in this memo.
