> As you know Gail my wife and I walked in for the first time into a DPSS
> Office on August 17, 2012.
>
> It is with incredible sadness that I must say this again, I have been so
> incredibly surprised on so many occasions by actions taken by the
> Lancaster California DPSS Office that frankly I no longer take the risks
> in understanding what your office is as well as not saying and not
> communicating with all of its communication [letters sent by United States
> mail, your websites, your communication either in person or on the phone].

> With all due respect that screen print does not in any way shape or form
> communicate to me what you wrote:

> "The notice that you received is letting you know that effective May 31,
> 2015 your CalFresh Certification period will end. Therefore, you need to
> recertify to prevent termination. A CalFresh recertification packet has
> been mailed to you and a Telephone interview appointment has been set up
> for you for May 05, 2015 at 8:45 am."

> However, in an attempt to move on to the best of my knowledge I have yet

> 4. So, the bottom line is not only are you not helping someone that is
> disabled but you are causing him [yours truly] great problems and
> hindrances.
