Dear DSS Director Manuel Romero

This Open Letter is an attempt for the agency that you are responsible for to put a hold on finalizing any Decision that it is attempting to bring about in the following case numbers:

173110249-IHSS  
173110251-FOOD STAMPS

I received letters from your Governmental Agency on Wednesday, April 4, 2018. This was a normal kind of day that we went "into town" to run a numerous set of projects. I am writing you this because it is relevant to what I am about to tell you. When we do the kind of activities of this day at the end of it we are completely and totally exhausted beyond belief.
