02. This Open Letter:

I have debated for some time now about contacting you directly about these (SOP) documents that I have received since I began the process of filing for state appeals as a result of decisions made by your government entity that I have completely, overwhelming, and wholly convinced that I needed to fight within my very limited resources your government agency as I like to use the gentler and kinder phrase bad behavior.

I know of no law forbidding me from contacting you in these ways. La France Toliver went on to also tell me that you were just doing your job. I was deeply saddened that were it not for La France Toliver I would have never known

that, you were just doing your job.

Obviously, I do not have positive feelings about your employer. By all the evidence that is available to me they mistreat their "customers" and they mistreat their employees such as yourself.

04. My knowledge or the lack of it about (LACO DPSS):

While I believe that I know more than most of the 3.5 million Los Angeles County residents that are your government entity's "customers" there are vast amounts of information that I do not know about (LACO DPSS).

041. What I do not know about (LACO DPSS):

0411. I do not know whether it is acceptable to at the very least misinform that California Department Of Social Services (CA DSS), the judicial body that regulates (LACO DPSS) and all other county agencies like yours all the way to flat out lie to these Judges.

0412. I do not know whether it is just your "customers" that are open to criminal charges when they at the very least swear to tell the truth under the penalties of perjury.

0413. I do not know whether it is acceptable for (LACO DPSS) to perjure themselves and there is absolutely, positively, and overwhelmingly no consequences whatsoever to that doing so.

0414. I do not know whether the penalties of perjury do not even apply to (LACO DPSS) employees.
