Question one:

The two issues are intricately woven together because they go ultimately to my core beliefs. There is so much more than I can say about this but I believe that my "Political Bio"[01] document explains and answers these type of questions. However, there are footnotes at the bottom of this document that I believe greatly go into great detail about the issues that I am dealing with in this document.

Question two:

Can you tell us a little information about (LACO DPSS)?

Answer two:

The Los Angeles County Department of Public Social Services(LACO DPSS) as the name implies it is a Public Social Services government entity. I have done a great deal of research about this entity over the years since my awesome wife Gail and I walked in to an office in Lancaster California (office) for the very first time on August 17, 2012.

Some of the things that I have seen on their website, such things as:

They have a \$3.9 billion annual budget. They have not stated in the same place whether that budget only pays for the about 14,000 employees that they have.

We posted all of those documents in May of 2018. We did so because I believed the only way to win what would end up to be the Judge PALOMARES case we had no choice but posting them all for the whole world to see.

Question four:

Why do you Robert Colaco believe that (LACO DPSS) has retaliated against you?

Answer four:

In the state of California if a county government agency like (LACO DPSS) makes a decision that I as the "customer" (what the former Director of LACO DPSS calls us) do not agree with, I can ask the California Department of Social Services(CA DSS) to have an Administrative Law Judge (ALJ) review that decision and if that (ALJ) rules for the "customer" then (LACO DPSS) "is supposed to do what ever that (ALJ) has ordered for them to do."

In the last three (3) successful rulings in favor of the "customer" yes, that means my awesome wife Gail and I, yet, as I have said that they have treated those judicial rulings as meaningless trash not even recyclable trash. I have also said to high ranking officials of (LACO DPSS) that based on all the evidence that is available to me that (LACO DPSS) employees have been given a license to lie, cheat, and steal.

In one such instance Judge PALOMARES said to the county representative something to the effect of:

"How can you say that Mr. Colaco did not tell the county where he was living when he had put where he was living at the very top of the form and also at the bottom of the form in the signature area where it was not even necessary for him to do so."

In my opinion Judge PALOMARES was attempting to stop the county representative from committing perjury. She appeared to not care about that one iota.

It is in fact this judicial ruling that Judge PALOMARES ruled in our favor that is the subject of my October 10, 2019 lawsuit/petition.[03]

Question five:

Why are you Robert Colaco writing about this now?

Answer five:

At about 6:00 PM on February 20, 2020 I discovered two electronic notices (EN) on the (LACO DPSS) website. The first (EN) telling us that they are decreasing our (CF) until we have paid back what we "owe them"[04]. That is one of the three judicial rulings that we won that they have treated as if the judicial rulings never actually happened. Hence, my phrase they are treating the judicial rulings as meaningless trash not even recyclable trash.

Again at 6:00 PM on February 20, 2020 I discovered an (EN) that stated:

"Proposed Decision Your General Relief (GR) cash aid will stop on 02/29/2020, unless you act before 02/24/2020. Reason for Proposed Decision Your GR cash aid is set to stop because you did not complete the following requirement: You did not turn in a completed State Supplementary Payment on time."[05]

I have no idea what "You did not turn in a completed State Supplementary Payment on time." actually means. The only potential "State Supplementary Payment" that I can possibly think of is what I said about the first (EN) directly above. However, this is only speculation on my part. They have also been decreasing our (CF) since January 2020 by about 10%.

In an effort to show complete and total honesty and integrity I am posting both of those two electronic notices (EN) [04] and [05] for the whole world to see. And, I have quoted (") exactly from the documents in question.

"Hearing Information

A hearing has been set. A hearing is a meeting with a Hearing Officer who was not part of the original decision. You should go to the hearing if: 1. You think this is a mistake; or 2. You have a good reason why you did not comply. When is my GR hearing? Monday, 02/24/2020 09:00 AM Where is my GR hearing? 067 Lancaster General Relief Office 337 E AVENUE K10 LANCASTER, CA 93535-4539"

One of the evidence points that I am being retaliated against is the above "Hearing Information" even though I have stated to high ranking (LACO DPSS) officials on numerous occasions that I believe my freedom is at risk by walking into any of their offices. Also, because of how (LACO DPSS) has impoverished us so we no longer have a working vehicle.

In fact, Michael Guerra one of those high ranking officials arranged for me to have an online video conversation (so that we could have a "face to face meeting") with a worker and a manager in January 2020. Having qualified for (GR) since December 2018, basically having less than \$100 in total liquid cash. But only having received (GR) now after having it for about one month they want to take it away in a retaliatory fashion.

Question six:

Robert Colaco, has (LACO DPSS) done more retaliatory actions towards you?

Answer six:

Yes, the lawyer representing (LACO DPSS) in actuality Los Angeles County filed an Anti-Slap Motion against me after demanding that I withdraw that lawsuit/petition which I refused to do.

Basically, as I have come to understand it, an Anti-Slap Motion is an attempt to get the court to have me pay for the legal fees and costs of Los Angeles County because I brought a lawsuit/petition for violating the first amendment rights of free speech for Los Angeles County (a person) for the amount of \$5400. Yes, as un-believable as this sounds please believe it. Please read my prepared remarks spoken to Judge Brian C. Yep on February 6, 2020[06].

I brought the lawsuit/petition in an attempt to get (LACO DPSS) and or (CA DSS) to comply with the Judge PALOMARES ruling. Instead it was clearly communicated to me that bringing a lawsuit/petition got me slapped down (pun intended).
