01. INTRODUCTION:

- 01.01. It is my strongest hope, desire, and goal to not sound or be rude, unkind, or to show any disrespect as I make my following remarks.
- 01.02. It is also my strongest hope, desire, and goal to communicate with you as truthfully and clearly as I possibly can so that you would understand what I am trying to say to you and thereby no misunderstandings between us develops any more than it already has.
- 01.03. To that end if you believe there is a misunderstanding or something does not make sense to you, please do not hesitate to call me.
- 01.04. It is however my complete and total expectation that you would have read my entire letter, not just skimmed it, or done something like just looking at the first and last paragraph.

02. This document is somewhat different than the many documents that we have sent to you folks. Since we are having to use "Evidence" from external sources, we need to have certain communication about this "Evidence" and what we need to do with it:

02.01. Links are typically very long and while long links that wrap around the page will work in an email, they will not work in a document like a pdf. The wrapping breaks the link. So the user is forced to try swiping and pasting the whole link into the browser address bar rather than clicking it in the page.

02.01.01 As example if I use the "PDF VERSION" of the New York Department of Health website page which is used later in this document we will have this wrapping issue.

02.01.02 New York Department of Health website address shown here as an example:

02.01.03 The link is clickable and will work as expected when you are within your e-mail. However, it is too long, a website link in our PDF which we post on our website. It will work in email but word wraps on the printed pdf page. It is for this reason that we have changed our policy from having really long website links/names because if the website link goes to another line in that document then that link will not work unless you copy the entire link. As an example with the website link above in "02.01.02." you need to copy from the letter "h" in "http" to the "f" in "pdf" that is the last letter.

02.02. That is only one of the reasons we post a "Mirror/Backup:" of the page on our website(s) and include the link in our documents. The other is that pages disappear or the link stops working and you get a 404 error or something like it. So, below not only will you see the website address of the non CITIZENS FOR A BETTER AMERICA(R) (CFABA.ORG) website address but you will also see the CITIZENS FOR A BETTER AMERICA(R) (CFABA.ORG) website address that will have the "Mirror/Backup:".

02.02.01. Many years ago we saw that documents and other files would disappear from the Internet. This is even before companies like Google who owns Youtube began to censor content that they did not like. As a result we made the decision to have that file(s) hosted and posted on a website that CITIZENS FOR A BETTER AMERICA(R) (CFABA.ORG) controlled, where our files are permanently posted on those websites and at their permanent website address.

02.03. We are using the "Evidence" from external sources under "Fair Use":

02.03.01. "Fair use is a legal doctrine that promotes freedom of expression by permitting the unlicensed use of copyright-protected works in certain circumstances. Section 107 of the Copyright Act (<http://www.copyright.gov/title17/92chap1.html#107>) provides the statutory framework for determining whether something is a fair use and

identifies certain types of uses—such as criticism, comment, news reporting, teaching, scholarship, and research—as examples of activities that may qualify as fair use."

03. Here are some of the details of what we did and why. My awesome wife Gail helped me find the following information:

03.01. Whether or not we can submit the form electronically is not in dispute.

03.01.01 The Your Benefits Now(YBN) website is a form of electronic submission. It also provides authentication as the account is password protected and we are the only ones who can upload to our own account.

03.01.02 What is not being allowed that was previously allowed is the use of an electronic signature on the document and thereby avoiding the need to print, scan, etc. the document and the risks and costs entailed in doing that.

03.01.03. Is the use of a separate page with a signature or signatures valid?

03.01.04. Yes!

04. Evidence:

04.01 It is an acceptable method of agreement in use by a different state government.

04.01.01. If you search the exact term: "wet signature on a separate page". The search will take you to documents in the New York Department of Health website. Specifically the Community First Choice Option (CFCO) GUIDELINES.

04.01.07. Just in this example we see a state government using a "wet signature on a separate page", and deeming it acceptable.

04.02. It is an acceptable method in use in contract law.

04.02. Baker McKenzie in their online publication, How to Execute Contracts Electronically While Working From Home, Dated 30 March 2020, deals with this issue as well as others, see link below:

04.02.02. Baker McKenzie in their online publication tells us that:  
"In practical terms, the following e-signatures are generally accepted in the US and Canada:

The "sign and scan" approach, where parties sign, scan, and email a signature page to be affixed to a soft copy version of a final contract"

04.02.03. This is even beyond what we have submitted.

04.02.04. Later they tell us:

"In addition to e-signatures, the laws in effect in North America provide that a contract or record will not be denied legal effect or enforceability solely because it is in electronic form. For this reason, exchanging soft copies of documents electronically will not affect the validity of a contract under these laws. In addition, if a law stipulates that a record is required to be in writing, an electronic copy of such record complies with the law."

04.03. If you do another search for the terms "signature block on a separate page" you will discover that it is used plentifully and in many situations. The only hazard

seems to be to the signer not to the recipient of the signed document.

04.03.01. A user at the adobe.com community says it well:

"Digital Signature, unlike "wet" signatures, apply to the entire document as a whole, not just to the page where the signature is located.

If someone could add new pages to a document you signed and it would appear you agreed to those pages without having seen them before you won't be too happy, would you?"

"Is it permissible to have a signature block on a separate page from the body of the document?"

"It is not a secure practice. A signature attests to whatever is in a particular document. If the signature is on a separate page by itself, any number of additional pages could be inserted, or that page could be attached to ANY document!"

04.04. The solution to this potential damage or danger to the signer is to link the signature block to the document.

04.04.01. California Code, Government Code - GOV § 16.5 lays out at least these requirements for a digital signature:

- (1) It is unique to the person using it.
- (2) It is capable of verification.
- (3) It is under the sole control of the person using it.
- (4) It is linked to data in such a manner that if the data are changed, the digital signature is invalidated.

04.04.02. While this is not a digital signature, as that was not acceptable any longer, we felt, using these rules as a guide could only help to protect us.

04.04.03. We have done that with a handwritten statement written on the signature block page.

04.04.04. We have stated the following:

"The wet signatures below are intended to replace the electronic signatures dated December 01, 2020, which showed our agreement, and are already placed on the SSP-14 form dated 10/04/2020 and this signed page is invalidated if the data are changed, or the page is attached or applied to any other document."

04.05. Has the signer shown intent in the signing?

04.05.01. Yes, the wet signature is the replacement to the electronic signatures as stated on the signature block page.

04.05.02. Those e-signatures when used on forms submitted previous to this change had been an agreed to acceptable form of signature to show intent of agreement of the parties signing. In stating the replacing of them that intent is confirmed. It is also stated so on the separate signature.

04.06. Is there authentication?

04.06.01. Yes, as stated above in section 03.01.01 of this document:

"03.01.01 The Your Benefits Now(YBN) website is a form of electronic submission. It also provides authentication as the account is password protected and we are the only ones who can upload to our own account."

04.06.02. Also at e-sign vendor signix.com they state the following:

04.06.02.01. "When it comes to digital signatures, that means using a process called "authentication." Signers can prove their identity by confirming their username and password,..."

05. CONCLUSION

-----

05.01. Why all this trouble over signing a document?

05.02. When my awesome wife Gail wrote much of the text of this document she stated:

05.02.01. "We will leave that for a separate Commentary or Email or Document or lets just say Communication at another time. I Robert Colaco have made my protest known to the parties at laco dpss and have also contacted the Los Angeles County District Attorneys Office as well as the Los Angeles County Sheriffs Department."

05.03. This added signature page should be sufficient to meet the required "Wet Signature" need you requested, demanded and we have an expectation that our GR Benefits will continue without any penalty, delay, harassment and retaliation. By that we expect to see our December GR Benefits added to our EBT before account no later than your departure from the office today, Thursday, December 17, 2020 since this is your last workday of this week. We uploaded that SSP14 document with our electronic signatures and we showed Good Faith in our compliance of doing so.

05.04. In the follow-up to "05.02." and "05.02.01." I would believe and feel that it would be almost irresponsible of I Robert Colaco to not state for the written record that what I believe was done to me by your "Policy Section" was among the following:

05.04.01. An abuse of power. Why do I say that? Because, of all the evidence that is available to me they appear to be on some "Power Obsession" to see how much they can abuse, humiliate, destroy people's lives and obviously be able to not only get away with it all but appear to get some satisfaction from all of that.

05.04.02. The abuse of us Robert and Gail Colaco by putting the horrible scenario of losing our General Relief(GR) of \$375 per month which we desperately need and qualify for.

05.04.03. Michael Guerra: As you will remember we qualified for General Relief(GR) as far back as December 2018 but did not receive that General Relief(GR) until January 2020 that was a direct result of what appears to be the horrible, disgusting, and despicable actions of your "Policy Section".

05.04.04. Michael Guerra: Again, as you will remember since I bring up these issues with you on a regular basis we qualified for General Relief(GR) as far back as December 2018 because when we received the Administrative Law Judge(ALJ) ruling by Judge ELI PALOMARES on October 10, 2018[111] the Los Angeles County Department of Public Social Services (LACO DPSS) treated that ruling as I have said on numerous occasions in conversations with you: "as meaningless trash, not even recyclable trash."

05.04.05.01. Michael Guerra: Again, as you will remember as I have I did what that ruling stated to do which was as follows:

This lawsuit under the section "Appeal Rights" states the following:

05.04.05.02. "You may ask for judicial review of this decision by filing a petition in Superior Court under Code of Civil Procedure 1094.5 within one year after you receive this decision. You may file this petition without asking for a rehearing. No filing fees are required. You may be entitled to reasonable attorney's fees and costs if the Court renders a final decision in your favor. You may contact Legal Services for assistance."

05.04.06. Michael Guerra: Again, as you will remember I did exactly what "05.04.05.02." said to do. Under the leadership of the Los Angeles County Board of Supervisors[099] I was further abused by them and your department (LACO DPSS) by having your collective lawyer by the name of Anita Susan Brenner telling me in a phone conversation that if I did not drop my Petition/Lawsuit that she will attempt to bring a judgment against me for over \$5000 because I violated the First Amendment rights of free speech of the County of Los Angeles "A Person".

05.04.07. Michael Guerra: Again, as you will remember I have told you on numerous times this is third world, or third world banana Republic tactics like the one that I was born in Iraq[114] and it's dictator Saddam Hussein.

05.04.08. Michael Guerra: Again, as you will remember I have complained about the Democrat controlled cities, counties like this one it appears that at the writing of this Open Letter to you on Thursday, December 17, 2020 that the Democrat Party has succeeded in stealing the election and bringing about the dictatorship of Joe Biden and Company.
